THE GCSA CERTIFICATION PROCESS

Designed to examine the business operational procedures described by sponsors and CROs as the critical areas underpinning the delivery of high-quality trials, the GCSA certification process covers the following seven areas: Governance, Workforce Process Quality, Site Business Strategy, Patient Engagement, Feasibility, Study Start-Up & Initiation and Study Management Operations & Close-Down.

To gain true insights, the GCSA assessment team at the International Accrediting Organization for Clinical Research (IAOCR), undertook a deep dive review of Revival's documented processes and procedures, assessing these against the global best-practice standards
